INTRODUCTION

A bibliography, compiled at the NACA Lewis laboratory, of classified reports specifically connected with or closely related to the aircraft-fire problem is presented as a supplement to the "Bibliography of Unclassified Aircraft-Fire Literature" (Reference 1). The reports listed were issued during an approximate 20-year period ending January 1, 1949. The literature is alphabetically arranged by author; an author index is included.
